- 3. ESG, Corporate sustainability and legal accountability;
- 4. The role of law in energy transitions and renewable resource management;
- 5. Environmental justice and the protection of vulnerable populations;
- 6. Legal Strategies for Sustainable Cities and Communities;
- 7. Artificial Intelligence, Law, and Sustainability.

This year, the Católica Graduate Legal Research Conference 2025 proudly precedes the 3rd edition of the Lisbon Climate Conference, occurring on October 24th, 2025. While seeking to offer a dynamic platform for graduate students and early scholars to expose their work to constructive feedback, our goal with this year's format is also to advance intergenerational dialogue, encouraging the encounter of different generations of academics seeking to shape innovative solutions in the pursuit of a sustainable future. Subject to peer review, final papers have the possibility to be published in *Católica Law Review*.

Ph.D. candidates are thus invited to submit an abstract of about 500 words, in English, by July 15th 2025 at the latest, at the following email addresses: lisbonclimateconference@gmail.com and mermida@ucp.pt. Submissions should mention you are submitting your abstract to the Católica Graduate Legal Research Conference 2025 and include a *curriculum vitae*, with email and institutional affiliation.

Abstracts will be assessed based on:

- Originality and the innovative nature of the work;
- Relevance to the overall conference theme; and
- Coherence of panels and the conference as a whole.

Only one abstract per person will be considered, but joint submissions are admitted.
